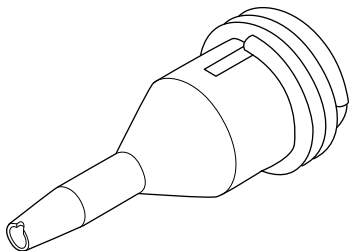

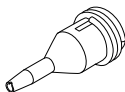

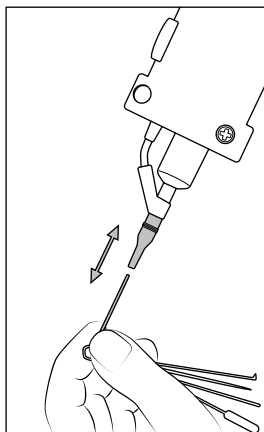
Tip care

The largest rod that fits in the tip hole should periodically be passed through in order to clean the intake tube.

The microdesoldering tips are protected against oxidization and wear.

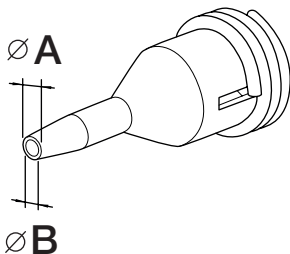
Do not use abrasive tools which may damage the tips protective surface coating and avoid knocking them about.

To maintain the tips, use the recommended cleaning methods (brass wool, brushes, sponge). Only use the TT-A re-tinner when absolutely necessary.
